



effect. Repeat if necessary after some days. To reduce annoyance from bedbug treat hiding and breeding areas where these pests may alight or congregate in similar manner.

General Application information of GoGo-Out as Dust and Liquid Spray :

- 1. Make survey & identify the problematic areas of bed bug occurrence. We can stop entry in particular areas.
- 2. The bed bug proofing is done by creating an artificial barrier to furniture or sleeping places to protect areas of their food & habitat.
- Break open pouch, Place the Powder to create an artificial barrier continuously at beddings,dry cloths etc without leaving any gap. The duster pump/ modified blower can be best application tool for spread of powder.
- 4. This material is solid & is insoluble in water so dust directly for spray purpose mix GoGo (@10gram per litre) all places where bed bug can hide. At wall pieces, furnitures, cracks, empty spaces in such a way that it will remain there as a residual material.
- Dust GoGo-Out powder at all the linen placing stores, windows and door sides to take care of either hiding or entering in home or sleeping places. Study the situation and apply at required places.
- 6. Apply spray at all the possible or hiding suspicious places wherever dusting is not possible like top ceilings & dust over the ground dry articles.
- 7. Try to go by integrated approach covering maximum infested own areas with neighbour herborages of infested area also.

HOW TO USE :

- 1. GoGo-Out shall be dusted across an areas where it is desired to prevent or discourage bed bug from entering .
- 2. Preferably, the dusting shall be 10-30 cm wide, although generally the wider the spray barrier is the better.
- 3. In this manner, an odourless descicant barrier is provided that bed bug are reluctant to cross and die of drying if they cross, for the entire society, houses, hotels or rooms. All at once.
- 4. Additionally a smaller amount of product may be scattered in diffuse or non-continuous manner just beyond the strip on any beding, furniture on the side away from the area to be protected.
- 5. This added Dusting/Spraying scattering of repellent serves to lessen the probability of occasional bed bug wandering beyond the strip.
- 6. A portable dusting pump can be made available by separate payment of Rs 200/- by courier
- After use dispose the pouch by deep burial in jungle areas. First try to understand Biology habitat of bed bug, later think of doing this as preventive measures for self-protection before application.

Frequently Asked Questions

QUE: Is this product spray work out to get out Bedbugs?

ANS: Yes. Indeed. Make dusting across area desired to create an artificial barrier prevent/discourage from entering. Dusting lessen probable entry. If barrier line is broken, re-apply. Spraying is also done @10 gram/Ltr of water where dusting is not possible

QUE: How to apply around my hut?

ANS: Use by direct dusting for making barrier to Bedbugs for killing it. For top portions, wall ceiling spraying is option.

Mix 10 gm powder in a liter water to spray. It works lil late after loss of moisture.

QUE: Hi I want to get rid of Bedbugs from my farmhouse. Is this medicine proper for that ?

ANS: Yes Indeed it is useful & very effective safe if used as per instructions. It start working on the day of application.

QUE: Is this product work in any season ?

ANS: Yes, all seasons. In Summer, winter dusting remains naturally effective & gives protection but in monsoon repeated

dusting is required

QUE: Frequency of spraying?

ANS: Spraying and dusting Frequency @15 days is required , once powerful application is done to make an artificial barrier line we can get rid of the bugs bite on the day of application.

QUE: Does this product affect pets or humans?

ANS: No but It's safe to all Human & pet. It's safe once applied with precautions while applying.

QUE: Can I use this product when i have other pets on my farm land? I have hens, turkeys, bunnies and birds. Is it poisonous when other animals consume it?

ANS: Yes. Use it at Bedbug prone areas of farm & in cages for ecto-parasites. It's not consumable still safe to animals.

we can get rid of the bugs bite on the day of application.

QUE: Does it repels Tick, Flea, Mite,Louse & bugs as well?

ANS: Yes It does.we can get rid of the bugs bite on the day of application.

QUE: if once apply how long days it will be effective, how long days once have to change?

ANS: 10-15 days if undisturbed. Re-apply at problematic houses. It is reapplied anytime for repair if the barrier line broken, it's soluble in water so get washed, still to ensure protection go for re-application.

GoGo-Out: How to Use! SOP (Standard Operating Procedures)

24.11.18

Back ground Before Application of GoGo-Out try to know biology & habitat of Beg-bugs, then use GoGo-Out as preventive & curative measures. The product is designed repel & eradicate Bed-bugs from Human habitat. Urbanlife, Hotels, Food-factories, Farm houses /sheds of livestock, Horses. Bedbug is parasite feeding on blood of animals like Human & almost all others. Its as much as a hidden, nocturnal and blood sucking organism. Behavior of Bedbug is to move slowly in a deliberate and investigatory manner searching blood smell. In our experiments we have seen bedbug 's responses to the GoGo powder in as near to natural -normal conditions as possible, so we recommend to apply GoGo-Out by dusting/spraying across an area where it is desired to prevent or discourage bedbugs from entering. Preferably, the Dusting/Spraying should be done in a strip 10-30 centimeters wide, although generally the wider the strip the better. In this manner, a contact barrier of GoGo-Out is provided to which bugs are reluctant to cross. Additionally, a smaller amount of the Dusting/spray may be done as scattered in diffuse or non-continuous manner just beyond the strip, on the side away from the area to be protected. This added scattering of the repellent serves to lessen the probability of occasional bugs wandering beyond the strip. If Dust/ Spray barrier line is washed/broken, GoGo-Out shall be re-applied on to repair the barrier, but protected from heavy rainfall. After washing, cleaning or rainfall re-application shall be done.GoGo- Out is insoluble in water so does remains there in the same places still to ensure protection re-application is recommended . In experiment bugs exhibited even overt avoidance of the repellent, and if sometimes some bugs try to cross the repellent. These exhibited avoidance behavior first, eventually moving across the repellent strip while rubbing the head against the ground, seemingly attempting to escape from the repellent spray -strip. Every time start treatment at interior sections working outward. Create complete perimeter around areas to be protected in every bed room after every 15 days (Not to be used by persons with dust allergies). Keep away from children.

DIRECTIONS : GoGo -Out is a Solid non -aromatic powder available in pouch (with attachable nozzle for spraying or dusting separately). The pouch content is 60 Grams. The person dusting/spraying the GoGo-Out shall wear protective dust mask & goggle before start.

INGREDIENTS:

Proprietary Blend of natural diatomaceous earth as active ingredients. (See MSDS for all ingredient details.) 1. Break open the pouch seal,Start dusting. For spray mount the spray nozzle tighten it. Switch off fan, door, windows to keep air flow in control.Start dusting/spraying areas of occurrence of bedbugs to kill, repel bugs as curative spot treatment. Scattered spray shall also done to discourage the pest.

2. Dusting/Spray GoGo-Out in infested areas to form an artificial barrier line continuously without leaving any gap in strip of 10-30 cm.

 At mounted wall piece, posture, photo-frame, electrical fixtures, bulbs, tubes in such a way that it will remain there for longer time as a residual material. Due care shall be taken while spraying at electric equipments
Place the GoGo-Out at all the parking areas, windows and door sides to take care of either pest bug hiding, breeding or entering places in home and premises.



5. Apply at all the possible or hiding suspicious places while doing so you may find some insects, Tick, mite, louse etc rushing away getting repelled if hiding inside. Please, note GoGo-Out repels several organism but does not harm to Human, animals, frogs, pet & even birds.

Note: Disturb Natural food chain, natural habitat of bedbugs they are enemies. They are most important part of blood sucking parasitic food chain. The natural parasite food cycle shall be broken at maximum possible ways. In exceptional case apply GoGo in for preventive artificial barrier it is very necessary in human areas to keep bugs away, later it shall not be broken it's not required. Do attempt to cover very big buildings, entire Home, hotel, hospital, society, urban areas and entire premises use for Home, Hotel, Hospital & Food industry.

Disposal: The empty container & remaining, after use shall be disposed by deep burial in barren land safely.

Storage: Store below 30°C Temperature in cool dry place away from children. Made in the India.
