## General Application information of MokshX as Dust and Liquid Spray:

- 1. Make survey & identify the problematic areas of Cockroach & Pests occurrence. We can stop entry in particular areas.
- 2. The Pests proofing is done by creating an artificial barrier to sleeping places to protect areas of their food & habitat
- 3. Break open seal of powder-puff bottle, Aim at Cockroaches& other pests, their staying places, make dusting to create an artificial barrier continuously at kitchen's or drainage by MokshX powder without leaving any gap. Ensure the duster pump fitted with pipe at the top head. Attach If the duster pipe is detached. Puff duster is best applicator by this tool spread of powder is possible uniformly.
- 4. This material is solid & not soluble in water so dust all places where Pests can hide. At wall pieces, furniture's, cracks, empty spaces in such a way that it will remain there as powerful desiccant.
- 5. Dust MokshX powder at all the linen placing stores, windows and door sides to take care of either hiding or entering in home or sleeping places.
- 6. Apply Dust at all the possible or hiding suspicious places wherever possible at top ceiling, & dust over the ground articles.

#### **HOW TO USE:**

- 1. MokshX shall be dusted across areas where it is desired to prevent or discourage Cockroach & other Pests from entering.
- 2. Preferably, the dusting shall be 10-30 cm wide, although generally the wider the spray barrier is the better.
- 3. In this manner, an odourless descicant barrier is provided that pests are reluctant to cross and die of drying if they cross.
- 4. Additionally a smaller amount of product may be scattered in diffuse or non-continuous manner just beyond the strip on any bedding, furniture on the side away from the area to be protected.
- 5. This added Dusting scattering of repellent serves to lessen the probability of occasional Pests wandering beyond the strip.

After use dispose the puff-bottle pouch by deep burial in jungle areas. First try to understand Biology habitat of pests, later think of doing this as preventive measures for self-protection before application.

## **Frequently Asked Questions**

QUE: Is this product spray work out to get out Cockroaches?

**ANS: Yes. Indeed.** Make dusting across area desired to create an artificial barrier prevent/discourage from entering. Dusting lessen probable entry. If barrier line is broken, re-apply.

QUE: If once apply how long days it will be effective, how long days once have to change?

**ANS:** 10-15 days if undisturbed. It is reapplied anytime for repair if the barrier line is broken, it's soluble in water so get washed, still to ensure protection go for re-application.

QUE: How to apply in aquas spray around my hut?

ANS: Use by direct dusting for making barrier to Pests for killing it. For top portions, wall ceiling spraying is option. Mix @10gm MokshX powder in a litre water to spray. It works after loss of moisture.

QUE: How many days this powder will work on Farm House?

ANS: Once applied in correct dose it works forever if not washed, undisturbed, unbroken over time.

QUE: Hi I want to get rid of Cockroaches from my farmhouse. Is this medicine proper for that?

ANS: Yes Indeed it is useful & very effective if used as per instructions.

CockmaX: How to Use! SOP (Standard Operating Procedures)

**Back ground** Before Application of MokshX try to know biology & habitat of Cockroach & other Pests, then use MokshX as preventive measures of pests. The product is designed for protection of Human life, pet in Indian lands, gardens, Food-factories, farm to fork from troubles of Cockroaches & ecto-parasites. Behavior of Cockroach & other Pests is to move slowly in a deliberate and investigatory manner actively at night.

In our experiments we have seen Pests responses to the repellent in as near to natural-normal conditions as possible, so we recommend to apply MokshX Powder by spread on the ground across an area where it is desired to prevent or discourage Cockroaches & other pests from entering . Preferably , the Powder should be spread in a strip 10-30 centimeters wide, although generally the wider the strip the better. In this manner, an odour & contact barrier of MokshX is provided to which pests are reluctant to cross. Additionally, a smaller amount of the product may be scattered in diffuse or non-continuous manner just beyond the strip, on the side away from the area to be protected. This added scattering of the repellent serves to lessen the probability of occasional Cockroaches & other Pests wandering beyond the strip. If barrier line is broken, MokshX powder shall be re-applied on to repair the barrier, but protected from heavy rainfall. After heavy rainfall eroding soils the re-application shall be done. Though MokshX powder soluble in water so doesn't remains there in the same places still to ensure protection reapplication is recommended. In experiment bugs exhibited even overt avoidance of the repellent, and if sometimes some pests try to cross the repellent. These exhibited avoidance behavior first, eventually moving across the repellent strip while rubbing the head against the ground, seemingly attempting to escape from the repellent strip. Every time start treatment at interior sections working outward. Create complete perimeter around areas to be protected in every bed room after every 15 days (Not to be used by persons with dust allergies). Keep away from children.

**DIRECTIONS**: MokshX is a Solid non-aromatic powder available in bottle. The bottle content is 150 Grams. The person applying the MokshX powder shall wear protective before placement of the powder like dust mask & goggle before start.

#### **INGREDIENTS:**

Proprietary Blend of natural Diatomaceous earth (See MSDS for all ingredient details.)

- 1. Break open powder-puff at tip targeting specific areas to be protected. Switch off fan, door, windows to keep air flow in control. Start scattering as bar-line marking at areas of Cockroaches 7 other Pests occurrence to create an artificial barrier.
- 2. Dust the powder on the ground, linens, cloths, land areas from the opened powder-puff of the duster pump continuously without leaving any gap in strip of 10-30 cm.
- 3. Dust the MokshX powder at all the parking areas, windows and door sides to take care of either hiding or entering places in home and premises. Mark the area if possible.
- 4. At Kitchen/food places put in such a way that it will remain there for longer time as a dry (desiccant) killing material. Also at mounted wall piece, posture, photo-frame, electrical fixtures, bulbs, tubes in such a way that it will remain there for longer time as a safe residual material.
