5. Apply Animal Out at all the parking areas, windows and door sides to take care of either hiding or entering in home.
6. Apply Gel at all the possible suspicious places while doing so you may find some insects, Rats, frogs, small pests rushing away from their places if hidden. Kindly note to some extent it repels them also.
7. In open animal shed, Horse stable, apply directly as curative spot treatment for Pest-Animals directly.

QUE: How many days this power will work on Farms?

QUE: How to apply around my Frm house or hut?

Back ground Before Application of Animal Out Gel try to know biology & habitat of Organism, then use Animal Out Gel as preventive measures . The product is designed repel & eradicate Pest Animals from Human habitat , Urban - life, Farms , Hotels , Food-factories ,Farm houses /sheds of livestock ,Horses. These animals are generally not Pest but quiet animals in own place. Their behavior is move slowly in a deliberate and investigatory manner.

In our experiments we have seen Animals responses to the repellent in as near to natural -normal conditions as possible , so we recommend to apply Animal Out Gel by Direct Gel smearing at places of Animals habitats and physical touch activity across an area where it is desired to prevent or discourage Animals from entering or Mix 50 ml Gel in one kg of snacks available in local market and throw areas of Animal groups, for large area Add 50ml in 1 5 litre water and spray in areas of Animals movements to prevent their habits of staying inn. Preferably , the Gel baiting/spraying should be done in a strip 10-30 centimeters wide , although generally the wider the strip the better. In this manner , natural anti-feedant repellent based on animal senses like taste, touch-feel, smell, odour & contact etc. as an artificial barrier is provided . It works on natural inbuilt defense system of every organism . Additionally , a smaller amount of the drops may be done as scattered in diffuse or non- continuous manner just beyond the spray strip, on the side away from the area to be protected . This added scattering of the repellent serves to lessen the probability of occasional Animals wandering beyond the strip. If Gel barrier line is washed / broken , Animal Out Gel shall be re-applied on to repair the barrier , but protected from heavy rainfall . After washing , cleaning or rainfall re-application shall be done. Animal Out Gel is soluble in water so doesn 't remains there in the same places still to ensure protection re- application is recommended . In experiment Animals exhibited even overt avoidance of the repellent , and if sometimes some Animals try to cross the repellent . These Animal exhibited avoidance behavior first, eventually moving across the repellent strip while rubbing the head against the ground , seemingly attempting to escape from the repellent Gel drops- strip. Repelled Animal show no hesitation to leave the place . Every time start treatment at interior sections working outward . Leave Animal evacuation route open (1 side) to flush out resident Animals that may be present , close open area off this untreated area within 5 days . Create complete perimeter around areas to be protected after 5 days (Not to be used by persons with perfume allergies). Keep away from children.

DIRECTIONS : Animal Out is a liquid Gel aromatic suspension available in pet bottle . The bottle content is 100 Ml . The person applying the Animal Out Gel shall wear protective before start . The minimum requirement is Boiler suit, Gum boot , rubber gloves , full goggle, nose mask or full face mask with canister and or helmet as per the need of the situations.

5. Apply at all the possible or hiding suspicious places while doing so you may find some insects, frogs, rat, cat, dog, mongoose, small pests rushing away getting repelled if hiding inside. 
